# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.lmyasports.com and Lafayette Youth Baseball Association and governs data collection and usage. # **Collection of your Personal Information**

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site.
